**ORDER TO SHOW
CAUSE WITH
TEMPORARY
RESTRAINING
PROVISION**

Upon the affidavit of Santokh S. Badesha, sworn to May ___, 2010 with the exhibits thereto annexed, the affirmation of Warren B. Rosenbaum, Esq. dated May ___, 2010 with the exhibits thereto annexed, and upon the pleadings and all other papers heretofore filed and served herein, and due deliberation having been made, it is

ORDERED, that defendants show cause before a Special Term of this Court, Hon. Kenneth R. Fisher, JSC, the Justice assigned presiding, at the Hall of Justice, Civic Center Plaza, Rochester, New York on the 9 of June, 2010 at 9:30 a.m. of that day, or as soon thereafter as counsel can be heard, why an order should not be made and entered preliminarily enjoining and restraining the defendants and all those acting in participation or in concert with them as follows:

- A. Enjoining and restraining defendants Parminder S. Soch, Mandeep Singh, Ajay Singh and members of their immediate families from entering upon any portion of the GOR premises;
- B. Enjoining and restraining the defendants and all those acting in participation or in concert with them from making use of the confusingly similar name of "Gurudwara of Rochester Sangat" in communications with GOR members and GOR worshippers;
- C. Barring defendants and all those acting in participation or in concert with them from videotaping within the GOR premises except upon the express, written approval of the GOR General Secretary;
- D. Barring all persons entering the GOR premises from bringing in or carrying ceremonial swords or other weapons that could cause injury or threats to persons within the GOR premises; and

- E. Barring all persons from standing upon or speaking from the pulpit of the GOR except with the express prior approval of the General Secretary of the GOR; and it is further

ORDERED, that pending the return of this order to show cause and until further order of this Court, the defendants and all those acting in participation or in concert with them be and hereby are temporarily restrained and enjoined as follows:

(VRF)

- A. ~~Defendants Parminder S. Soch, Mandeep Singh, Ajay Singh and members of their immediate families are enjoined from entering upon any portion of the GOR premises.~~

- B. Defendants and all those acting in participation or in concert with them are restrained and enjoined from making use of the confusingly similar name of "Gurudwara of Rochester Sangat" in communications with GOR members and worshippers.

- C. Defendants and all those acting in participation or in concert with them are barred from videotaping within the GOR premises except upon the express, written approval of the GOR General Secretary.

D. All persons entering the GOR premises are barred from bringing in ceremonial swords or other weapons that could cause injury or threats to persons within the GOR premises; and

E. No persons may come upon or speak from the pulpit of the GOR without the express prior approval of the General Secretary of the GOR; and it is further

ORDERED, that service of a copy of this order to show cause and the papers upon which it is granted by personal delivery to the office of defendants' attorney, Michael Masino, Esq., at Harris Beach PLLC, on or before May 21, 2010 shall be deemed good and sufficient service of this order to show cause and the accompanying papers, and upon receipt of such papers, defense counsel be and hereby is directed to promptly give actual notice of this order to show cause and the terms thereof to each of the defendants named in this action; and it is further

ORDERED, that answering papers shall be delivered to this Court and to plaintiffs' attorneys of record not later than May 1, 2010, and reply papers, if any, shall be delivered to this Court and defendants' attorneys of record not later than May 4, 2010.
